REVISED COMMERCIAL FORMS TOOK EFFECT JULY 1

Changes to a number of residential, commercial, auction, and property management forms in the NC REALTORS® forms library are effective as of July 1. These forms have been reviewed by legal counsel to be in compliance with NC law and the practice changes required under the recent NAR

LEGISLATIVE & REGULATORY UPDATE

The 2024 legislative short session ended on June 28 with both chambers passing numerous bills related to the real estate industry. The adjournment resolution allows legislators to return several times over the next few months to address a limited number of issues including overriding gubernatorial vetoes.

<u>Senate Bill 802 - C-PACE Program</u> establishes the commercial property assessed capital expenditure program allowing owners of qualifying commercial property to apply for long-term financing by private lenders to pay for energy efficient and resiliency property improvements. The amount financed would be secured by an assessment to be imposed on the improved property by the local government that has chosen to participate in the program.

<u>Senate Bill 607 – Regulatory Reform Bill</u> includes the following provisions affecting coastal areas:

- Differentiates a geotextile sand tube with rock erosion control structures from terminal groins
- Increases the number of permits for the construction of a terminal groin from six to seven years
- Allows for the rebuilding of dams and piers without getting a new CAMA permit

And, finally, <u>Senate Bill 166 – 2024 Building Code Regulatory Reform</u> includes provisions on backflow preventers and septic tanks but also makes changes to the state building code. Gov. Cooper vetoed that bill on Friday, July 5, citing concerns over potential rising costs to consumers. However, we remain hopeful that there are enough votes to override the veto.
