CHAIRMAN'S CORNER



Hello 2024 Appraisal Committee Members and REALTORS®.

Thank you for your ongoing commitment to the 2024
Appraisal Committee. As we enter the Holiday season,
the Appraisal Committee would like to send our
heartfelt sympathy and prayers to our friends, relatives
and fellow REALTORS® whose lives have been so
profoundly affected by the recent Hurricane Helene

The committee voted to approve the framework for legislation for PAREA participants seeking an appraiser certification during our virtual meeting on Friday, September 6. I would like to thank Vic Knight and the PAREA work group for their hard work and dedication to this important issue. We discussed data collectors and agreed that some oversight is necessary. Background checks and possession of a license including real estate, home inspection or contractor's license would be sufficient in order to hold them accountable. We believe it is important that brokers, buyers and sellers know who the person is that comes to inspect their listings and that they feel confident in their conclusions. Finally, we established the criteria for an Appraiser of the Year award to be presented annually during the NCR Awards Ceremony beginning in 2025.

A recent article in WorkingRE magazine titled "The Great Debate on Appraisal Fees", addresses ongoing discussions about fees charged to consumers by mortgage providers and related settlement services. Read the full article here.

Many industry stakeholders participated in the discussion and provided feedback to the Consumer Financial Protection Bureau (CFPB). Stakeholders included residential appraisers, several State Mortgage Bankers Associations, the National Mortgage Bankers Association, Appraisal Organizations and the National Association of REALTORS® responded to the CFPBs request for information regarding the fees imposed in residential mortgage transactions. Most agreed there is a need for regulatory action and greater transparency around appraisal and appraisal management companies (AMC) fees. This includes separating the fee paid directly to the appraiser for valuations and the AMC on the TILA-RESPA Integrated Disclosure (TRID). These undisclosed

fees have provided the narrative that appraisal fees have "skyrocketed" in the past few years when it has become clear that the increase in the appraiser fees is due mostly to additional fees imposed by the Appraisal Management Companies otherwise known as "junk fees". The appraisal committee supports ongoing efforts to separate these fees on the TRID to provide market transparency to borrowers, lenders and appraisers. This is an important consumer protection that is long past due.

It has been an honor and a privilege to serve as your 2024 Appraisal Committee Chair. I would also like to thank the NCR staff assigned to the appraisal committee for their hard work this year. We at the appraisal committee have been lucky to have an incredible Staff Liaison in Denise Daly. I could not have done this without her. Past Chairs of this committee/section are well aware of what an excellent asset she is to both the committee and NCR. I don't have enough room in this letter to express how impressive Denise Daly is as an NCR staff member and a person. Incoming Chair Clair Aufrance will soon know the joy of working with her.

Wishing you a happy, healthy Holiday Season and a prosperous New Year! I look forward to working with 2025 Chair Clair Aufrance and the Appraisal Committee in the coming year to provide continuing support for NCR members.
